
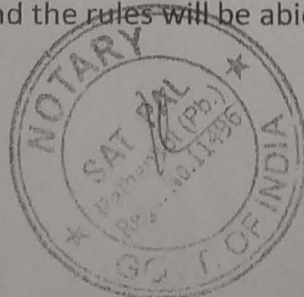


Regarding reference of above subject.

Keeping in view the documents along with Affidavits and the recommendation made by District Education Officer (Sec.Edu) Pathankot and director Education Department (Sec.Edu.) Punjab, Chandigarh, the necessary No Objection Certificate is being given by Punjab Government on the basis of the conditions written below :-

1. If it is found in future against any complaint or inspection that you have given wrong information to Government to obtain no objection certificate or the instruction of Punjab Government given time to time are not being abided by you and in this event the certificate of no objection can be returned back.
2. It will be compulsory to teach Punjabi language up to Matric level and CBSE New Delhi will make the efforts compulsory to take examination of Punjabi language and it is told that in case not doing so your affiliation will be taken back.
3. School Management will abide by the Notification issued by Punjab Government under RTI Act 2009 and the rules will be abided by RTI Act 2009 for Punjab State.

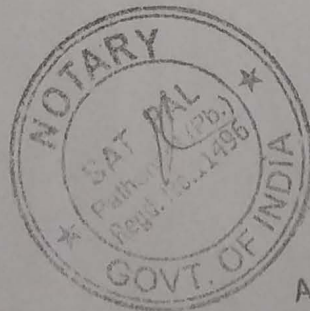
